The meeting was called to order by the President at 1:12 p.m.

Minutes: The minutes from the November 13, 2025 meeting were read and approved since a quorum was present. The minutes from the January 8, 2026 meeting were also read and approved.

Treasurer's Report: The treasurer was absent but there is 17,613.96 in the account with an outstanding check for \$20 still to be cashed. This is the same as last month.

Maintenance & Supply Director: The Maintenance and Supply Director was absent. The President noted the need to upgrade the outdoor courts with a Clay/Oyster Shell mix.
